### NOTICE TO EXHIBITORS

This show is Unbenched. Show hours are 8:00 a.m. to 5:00 p.m. No admission is charged. Dogs which, according to their owner's records, have completed the requirements for a championship after the closing for this show, but whose championships are unconfirmed may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made by the Show Secretary at least one-half hour prior to the start of judging at this show. A recording fee of \$.050 and and event service fee of \$3.00 will be required for each dog entered at any Licensed or Member Club show or Obedience Trial. This recording fee is to be collected by the show-giving club and paid to the American Kennel Club. (American Kennel Club Rules Chapter 11, Section 2.)

Class prizes will be awarded in the ring to the person showing the dog, who will be considered the owner or authorized agent. The Management and Show giving club disclaims any liability after the judging is over. Owners are responsible for errors on entry blanks.
