**INFORMATION FROM THE AVMA**

On Friday, March 23, 2007 a press release from the New York State Department of Agriculture and Markets ([www.agmkt.state.ny.us/release](http://www.agmkt.state.ny.us/release)) stated that the New York State Agriculture Commissioner Patrick Hooker and Cornell University's College of Veterinary Medicine Dean Donald F. Smith announced that scientists at the New York State Food Laboratory identified Aminopterin as a toxin present in cat food samples from Menu Foods, the manufacturer of the many brands of dog and cat food that are currently the subject of a nationwide recall.

The Food Laboratory received the pet food samples from a toxicologist at the New York State Animal Health Diagnostic Center at Cornell University, where testing has been underway to try to identify the cause of kidney failure in dogs and cats that consumed the recalled brands of pet food. At Cornell's request, the Food Laboratory tested the samples for poisons and toxins, and identified Aminopterin in the pet food samples at a level of at least 40 parts per million.

Aminopterin is a folic acid inhibitor found in some rodenticides available outside the USA. It is not available in the US as a rodenticide. Aminopterin is a 4-amino analog of folic acid. It was originally used as an antineoplastic agent in the late 1940's but has been superseded by methotrexate, a related but less toxic folic acid analog. At high doses, methotrexate results in acute renal failure and crystalluria due to desposition of 7-hydroxymethotrexate in the renal tubules. Aminopterin toxicity is thought to be similar and dose dependent.

These findings and any relationship to recent pet deaths have not been confirmed by the Food and Drug Administration. An announcement from the FDA is forthcoming. We need to be cautious as the finding of Aminopterin is significant but there could be other compounds yet unknown in the diet as well.

Recommendations for testing animals have essentially not changed. There is no blood test available for Aminopterin. Pets that have eaten the recalled food whether showing signs of illness (lethargy, vomiting, diarrhea, anorexia, etc) or asymptomatic should be seen by their veterinarian and have a complete blood count, biochemistry panel and urinalysis performed. Additional testing may include assessment for significant proteinuria, urine culture, imaging, etc.

Treatment recommendations have not changed. According to Dr. Richard E Goldstein DVM DACVIM DECVIM-CA, Associate Professor of Medicine at Cornell University, azotemic pets should be treated with fluids to promote hydration, and diuresis in order to dissolve and flush out crystals from the tubules. Aminopterin produces crystals within the renal tubules that are most soluble in an alkaline urine pH thus a target urine pH above 7 (achieved with fluid therapy and alkalinizing agents including sodium bicarbonate) might be beneficial in managing these patients. Several medications such as antioxidants and folic acid may be administered but their true beneficial affects are unproven when given long after the initial exposure to the toxin.

Bone-marrow suppression is a concern with any folic acid inhibiting agent and a complete blood cell count should be monitored in these patients as well as renal function.

If a patient with anuric or oliguric acute renal failure is not responding to appropriate therapy, veterinarians should promptly consider contacting a small animal internist with the American College of Veterinary Internal Medicine ([www.ACVIM.org](http://www.ACVIM.org)) in their local community for case consultation and possible referral. Hemodialysis can be utilized for severely affected patients and is available at a limited number of veterinary teaching hospitals.

Duration of treatment in patients which may have renal failure due to ingestion of the recalled food is unknown at this time and obviously will vary between patients. Long term effects on renal function are unknown but based on limited experience to date, at least partial renal recovery is anticipated. Patients succumbing to illness should be necropsied and tissues saved in formalin for histopathology to determine cause of death.

Samples for histopathology can be submitted to The Iowa State University Veterinary Diagnostic laboratory ([www.vdpam.iastate.edu](http://www.vdpam.iastate.edu)) or The Animal Health Diagnostic Center (AHDC) at Cornell University ([www.diag.center.vetcornell.edu](http://www.diag.center.vetcornell.edu)).

Samples of the recalled food should be held for possible analysis. Opened food should be disposed of so there is no chance of further consumption. Pet owners can contact the Food and Drug Administration (FDA) Consumer Complaint Coordinator at: <http://www.fda.gov/opacom/backgrounders/complain.html>.

The FDA has provided the following case definition for field investigation/cases: veterinary-documented renal failure, necropsy results if animal died, food consumed within 1 week of death (illness), and intact, unopened cans of the food. If veterinarians suspect that a case meets this general case definition, FDA has requested that you contact them at the following e-mail address

## The Best Of Breed Game

I think that the world needs a dog-show-oriented board game. Exhibitors crave something to fill those gaps between shows. I haven't worked out all of the details, but I thought you might be interested in my design so far.

I see a board not unlike Monopoly with shows instead of streets and really big shows like Westminster and National Specialties instead of Railroads and Utilities. Groups of shows are colored according to the "circuit" to which they belong.

**Blue** for the "Bible Belt Circuit"

**Orange** for the "Rust Belt Circuit"

**Pink** for the "Left Coast Circuit"

Interspersed among the squares are special green landing spaces, each of which corresponds to a deck of cards placed near the center of the board:

**A.K.C. Announcement**

**The Judge Speaks**

**Ringside Comment**

Players select little game pieces shaped to resemble various breeds of dogs and place them on the square labeled "Ready Ring".

Who goes first is determined by what is called a "Club Meeting". Participants scream, bitch, back-bite, cheat and lie about one another until at last it is obvious who goes first, second and so on. "Best Of Breed" is a kind of combination of "Monopoly", "Trivial Pursuit" and "Full Contact Karate". The player who ends up last is dubbed the "Judge".

Two pairs of dice are provided with the game : one normal, the other loaded. Players choose which to use based upon the level of realism they wish to recreate.

The object of the game is, of course, to finish your dog to a "Championship". This is accomplished by rolling the dice, moving your dog along the board, counter-clockwise of course, until you have completed fifteen complete circuits collecting a ribbon and a "point" with each successful revolution. Like the real dog show, if luck is not with you, you may be penalized along the way. If a player should land on one of the green squares, he must draw a card from the corresponding deck and read it aloud. He may, for example, land on "A.K.C. Announcement" and read, "Your entry form has been found to be incomplete. Return to the "Ready Ring". Give back your points", or on "The Judge Speaks" and read, "I didn't see him well that time. Take him around again." Landing on a "Ringside Comment" square doesn't hurt you in the point standing but just adds to the dog show flavor.

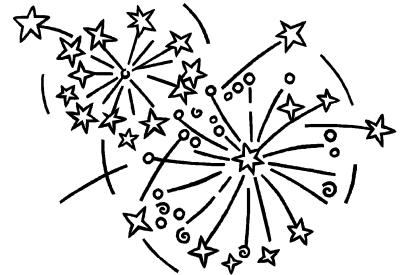
"How can he even think about putting that bitch up?"..."What an ugly dog!"...or..."She's not!...With Him?"

After one of the players has completed the mandatory fifteen trips around the board, the "Judge" names the player of his or her choice the "Winner" with no regard whatsoever to who has accumulated the most ribbons. Just like the real dog show, the "Best Of Breed Game" is fun, not fair.

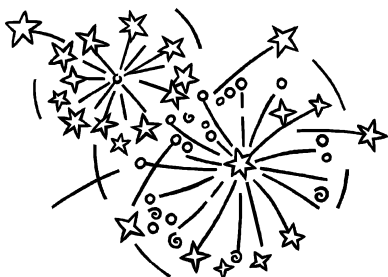

## *Linebreeding , Inbreeding & OutCrossing*

### INBREEDING, LINE BREEDING, OUT CROSSING-WHICH IS BEST?

To paraphrase the great Laura Kialenaus, what matters is the quality and qualities of the dogs in question; not the "formula" by which they are bred. Line breeding is often touted as some sort of special way to get good dogs. Line breeding is simply weak inbreeding, so carries all the problems of both out crossing and inbreeding & simply gives people uncomfortable with the idea of inbreeding a way to comfortably inbreed to retain desired characteristics. The degree of relationship, in any case, does not necessarily indicate the amount of genetic material shared. Everyone has seen two "identical" cousins, as well as brother-sister pairs as unlike as night and day to illustrate this point. Again, sophisticated decisions, based on in depth knowledge of what those pedigrees mean, are needed. To breed two dogs together (wisely and for good results) you must have intimate knowledge of the dogs in their respective pedigrees & what characteristics they likely share.

Out crossing: used to be (still is?) the time honored way to deal with a genetic problem. When your line shows a problem, breed out to "get rid of it." Except you don't --it is still there, now just hidden--along with whatever the sire's family also contributed "in secret". It may be back to haunt you (and your puppy buyers) later on. Document what you got & what you are getting. Outcross when you need a "hybrid state" for best expression. Outcross to bring things into your line you cannot find within it & know some unseen "travelers" will accompany the traits you desire. The best outcrosses may not really be outcrosses at all, as two separate families with similar styles & traits are merged together; different names, but maybe the same 'good' genes for good heads are present, for example, in both families. These trait or type breedings (assortive/assortative matings) are a strategy to get the "good" genes for a trait without doubling up on a specific individual. They have the extra added advantage to the breed (if not your specific breeding) of possibly helping to preserve diversity in the population. Of course, many "out crossings" wouldn't be that if extended pedigrees were viewed: many breeds & many major & successful bloodlines in a breed go back to a handful of the same relatives (& this is not necessarily a bad thing, if the dogs were good). Again, information on the dogs in question is so necessary.

Inbreeding: brings skeletons out of the closet. They were already there, but now you have to face them. It can be a great tool for finding out what you didn't know about your bloodlines, but it takes a steely heart to face up to what you find. It also takes great dogs to breed close as you are fixing traits fast and hard. The closer the breeding, the better the two dogs must be to make it worth it. Call weak inbreeding line breeding if you like, but breeding dogs closely related is technically inbreeding (although there is a good argument to separate the two), as the point is to double-up on desired family characteristics by doubling up on the desired genes. But most everything recessive in the family eventually pops up, good & bad, when line-breeding over generations, so eventually blind line-breeding leads to the same bottleneck as intense inbreeding; it just takes longer to get there. The bad news about inbreeding is that the homozygous sought may be found. In other words, you are trying to double up on genes for good heads or strong hearts, but also double up on the genes in the immune system & that can lead to inbreeding depression. So be careful what you wish for when inbreeding, especially repeatedly &/or tightly.

Brackett's Formula: "Let the sire of the sire become the grandsire on the dam's side." Lloyd Brackett's prescription for line breeding has proven very effective WHEN the dog line bred on is a truly superior example of the breed & can correct the weaknesses in the bitch/pedigree in question. Pat Craige Trotter in her book "Born To Win" discusses some successful strategies & possible formulas for particular situations, but no "cookbook approach" to dogs will ever work: breeding dogs is an artful science or a scientific art and takes both talent and study to properly accomplish. Out crossing can be like sweeping problems under the rug (if it is really an outcross that is done). The pups from two such lines now carry some mishmash of what either or both parents brought down out of their families.

KENNEL BLINDNESS. All breeders have their favored characteristics and pet peeves. All are willing to sacrifice the perfection of certain traits to consistently achieve others they feel more important. This "worldview" on their chosen breed(s) leads to a style and the emphasis of certain traits within the correct type that breeder will be known for (e.g. size, head type, longevity etc.). That many breeders have deliberate styles of dogs is good for the breed; it preserves the variety & strength of the breed. But many breeders fall foul of their own likes & dislikes, especially at the beginning when they know little about the breed and later on, as the years pass and they achieve some success, having now looked at the style they chose to breed so long they think of it often as the breed itself. If this quality is combined with an intolerance for one's rivals and/or for the faults least liked and virtues most admired, a good line of dogs will dwindle down to be more memory & reputation than a still truly vital line producing excellent dogs. Kennel blindness is also an almost universal trait of the "Sour Grapes Society;" those "wannabees" in a breed who have a thousand excuses for why their dogs don't succeed, all of them to do with the faults of other people and other people's dogs. It is also a major trait in so-called "pet breeders" who tend to not self-educate about the breed at all, so don't really know much about the breed they may well adore. They generally let their love for their pets blind them to their breeding worth...or lack thereof.

BREEDING "UP." This usually means using a well-known dog on a poor quality bitch in the hopes her offspring will succeed where she failed. Stripped down to this raw definition it's obvious what a bad idea this is. Stud owners should not let themselves be talked into breeding to sub-standard bitches & novices shouldn't attempt to get better pups this way. However it happens all

too often. But the outcome is nearly always the same: the proud owners of those new pups find they are not enough better than their mother to be competitive & the stud owner finds the reputation of the sire is damaged by those who see these poor quality pups as typical of what he produces. Stud owners shouldn't allow themselves to become this kennel blind. Worse is the idea of starting out with admitting "pet" animals & hoping (?) to breed something better somehow. This falls under the old saw about silk purses & sows' ears, but incredibly is still attempted \_&\_ defended as a way to start in dogs. You just cannot "get there from here." Surely there are more than enough dogs in this world without starting out deliberately to make mediocre litters. Enough said.

**BREEDING PEDIGREES (& other records), POPULAR SIRE SYNDROME & MATADORS.** Too many people breed "paper tigers:" they breed dogs who are relatives of a famous dog as if they were somehow magic or just as good, they breed to a dog's popularity, it's show record, it's fame, or even to their best friend's dog or the closest, most convenient dog. It's astounding as much as has been written in the last century about the perils of breeding "paper" that it is still done so often. A sire is only as good as his get & his get will equally reflect the bitches taken to him. It's no use to hope the one (or ten) good pup(s) you saw out of him will happen to you when your bitch isn't like the dams of those pups. It's even worse to think that his fame will arise in his litters; one cannot take the parents' show records into the ring to convince the judge of the merits of their offspring. Nor can you honestly think that a dog having "famous" grandparents gives you a reason to breed. Further, when certain sires are overused in a breed, these popular sires become a potential danger to the breed. If their influence is too widespread, then it becomes hard to breed away from them. Diversity of style as well as genes is lost in a breed. If said popular sire turns out to have a damaging genetic flaw, the Popular Sire Syndrome has now spawned a Matador--a dog whose late-recognized fault is now widespread enough in the breed to "kill" it. This is all bad practice. Selection is lost when a pedigree or fame is the deciding factor for the choice of breeding partner. It's ill-educated to breed to an ad or a reputation. It's a doomed effort (except for sales) to breed for convenience or to "see what happens." And terrible dogs are made by blind line-breeding: faults are fixed in & a good line is eroded over time. Each breeding must be done seeing the sire and dam as crowded in by their respective families when it comes to flaws, but standing alone when it comes to what virtues they can even potentially offer. There is, again, no recipe for breeding dogs & no substitute for a well-trained eye.

**PRESERVING QUALITY & GENETIC DIVERSITY IN A BREED.** As Dr. Jerome Bell so succinctly put it: "It is the varied opinion of breeders as to what constitutes the ideal dog, and their selection of breeding stock that maintains breed diversity." The current problem of erupting genetic disease, as far as it applies to pedigrees & breeding, reflects two trends. One is a problem of the "Matador," that is the "Popular Sire Syndrome." When all run to breed to a winning dog, or some dog or bloodline, (for whatever reason, be it convenience, ignorance or perceived value), genetic diversity can be lost. But indiscriminate universal assortative matings is not the answer to this problem & can actually reduce genetic diversity in the breed by "homogenizing" gene pairs across the whole breed. Out crossing cannot solve the problem of genetic disease anymore than inbreeding is the cause of it. However "type" breeding, that is, the mating of two animals of similar looks, not similar pedigrees, CAN effect one particularly good thing which is the take-home message of "diversity breeding": since the number of genes involved with creating a certain "look" are much less than the likely number doubled up with line breeding (esp. "blind" line breeding, time and again, on some "famous" relative), the loss to the breed of heterozygosity is slowed and the individual dogs are arguably more safe from various line defects...while still having "type."

The other major problems in dogs today as to disease has little to do with hobby ("show") breeders & is largely a problem of casual breeding. Casual breeding produces more than three-quarters of all registered dogs in the USA & assembly (nearly) 100% of mixed-breed litters. as a result of the low investment & high profitability (not just in money) that dog breeding brings to the average American household. There is a clear cultural support for anyone & everyone breeding their own pet, and this license runs counter to the serious study & self-education process necessary to breed dogs well enough to avoid bad temperaments and worse health problems. That so many pet buyers do not clearly see this means casual breeders are able to enjoy having litters, & be certain of sales, even if their only credentials are that they love their dogs. These litters, despite the buying public's perception & causal breeder's claims, suffer often from major genetic problems they continue to pass along \_and\_ they are often indiscriminately inbred, as they are usually exclusively local (or narrowly regional) breeding programs, often with the whole breeding population sustained by a couple of friends. What is needed is educated, dedicated, honest breeders & scrupulous selection. Breeders need to know the dogs they are using in their breeding programs & need to know them intimately. Each needs to have a clear priority of what they cannot live with & what they cannot live without. (And ideally each would clearly announce this somehow so others are clear on their priorities before they buy or breed from them.) A variety of styles, of lines, of sub-populations, criss-crossing, separating & then, again, coming together in a wonderful breed mosaic, is the best recipe for maintaining type, health, temperament \_&\_ diversity in any breed. And for all that "diversity" is a buzzword of fashion right now, it isn't at all a new idea, just a new term for the notion of having a variety of bloodlines within a breed. (Note also that diversity does not necessarily equal outcross.) What is needed in most all breeds is for more good dogs to be rooted out & recognized, despite their lack of glamour & dazzling ads. (That & for America to get serious about dog breeding & treat it with the gravity it deserves.) It would also help if more folks would work together to preserve bloodlines and create new ones by judicious crosses, so that variety would be preserved. For this more people will have to get educated about the history and styles of their breed; too many today simply breed to some current fashion )or market!), oblivious to the fact what they are seeing is simply fashion and not "the" standard for the breed.

SPORTS do not generally produce good offspring. Sport is a term many breeders no longer use, but is a useful idea. A sport is the odd good dog in a litter that is otherwise uneven. It is traditionally the occasional decent dog found in a litter from an unlikely background and breeding. Usually such dogs are the fortuitous result of a mixed litter from a casual breeding, & the people who breed to the dog are the ones who pay the price for his mixed-up, casual pedigree & genetic background. But sports can come about from breeding "paper" not dogs; from trying to breed "up," from blind line-breeding, or any convenience or accidental breeding. A sport is a dog by definition, almost, who is unable to reproduce himself, for all his good looks. Very uneven litters & erratic littermate traits result and are certainly not helpful to a breeding program & make it hard to track both good and bad traits with any likely success. Sports can play another negative role in the breed if they become famous show dogs (or just popular sires for any reason). Not only are they bred despite the fact they are indifferent sires, their every mediocre relative is used with great enthusiasm as the family is all thought consistently "good" (instead of seen for the inconsistent lot they really are). Breeding "paper" instead of dogs has a consistently poor result, but breeding dogs who cannot reproduce themselves should be recognized as a poor practice as well.

Great & consistent bloodlines have been built on good, consistent dogs bred by knowledgeable breeders. Purebred domestic species are based on concentrating family traits, so like dogs must somehow be bred together. Knowledge is the key here; knowing in depth what you are breeding. Buyers shouldn't reward those who breed casually, indifferently, or for superficial traits. And please don't condemn breeders who have the courage to acknowledge the faults in their dogs & their bloodlines (or who try to elicit information & public discussion of the same). All bloodlines carry along faults, not just the ones where the faults are seen & reported. Again, the situation now is too often one where people breed without knowledge, producing affecters and carriers & just not knowing it, as they don't keep adequate records, do enough homework, etc. Just ask yourself how this can be preferable to accumulating information than can only benefit the breed? Who exactly benefits from all this ignorance? Surely not the dogs, the potential breeding partners left in ignorance, or the potential puppy buyers. For the breeds to benefit from the control of genetic disease we need to do what most Code of Ethics demand: keep up with news in genetics & have an in-depth knowledge of the dogs we are using. This means understanding the basics of inheritance & knowing how to apply them for good results in your breeding practices. This means marking pedigrees with more than color and titles. This means accepting that most diseases we now struggle with have a genetic component & treating such situations conservatively AND rationally. We need to educate ourselves, to stop reacting violently to the notion of genetic disease & start treating it with a more sophisticated and realistic view. We need to not just learn as we go, but read before we breed, & bone up on the basics before we start creating lives.

- 1 carrot finely chopped
- 1 small potato finely chopped
- 1 stick celery finely chopped
- 1/2 c sliced green beans ( string less )
- 1 T beef gravy mix

Place all ingredients into a large casserole dish.  
Cover with water and mix. Place lid on casserole.  
Microwave on High for 10 minutes, then medium for 10 minutes. Cool well prior to feeding

### Hawaiian Style Chicken Over Rice

- 1 1/2 lbs boneless, skinless chicken breasts
- 1/2 teaspoon seasoned salt
- 2 tablespoons canola oil
- 1/4 cup frozen diced green peppers
- 1/4 cup frozen diced onions
- 2 cups instant rice
- 1 1/2 cups water
- 1 (20-ounce) can diced pineapple (drained)
- 1 (18-ounce) jar sweet and sour sauce

1. Preheat large sauté pan on medium-high 2–3 minutes. Cut chicken into bite-size chunks and sprinkle with seasoned salt
2. Place oil in pan; swirl to coat. Add chicken, green peppers, and onions (wash hands); cook 6–8 minutes, stirring often, or until internal temperature of chicken reaches 165°F. Use a meat thermometer to accurately ensure doneness. (Thread 2 or 3 chunks of chicken on thermometer to make sure the dimpled "sensor" area is covered.)
3. Meanwhile, place rice and water in microwave-safe bowl. Cover and microwave on HIGH 5–7 minutes or until rice is tender and most of water is absorbed.
6. Reduce heat on chicken to low; stir in remaining ingredients. Cook 2–3 more minutes, stirring occasionally, or until sauce is thoroughly heated. Serve over rice.

# Rally....A New Insight

Last month I attended a local all breed show. One of our club members told me that I really needed to try a few of my champions in this new sport and get a new title on them. He said that even a dummy could do this ! And if even I am stubborn and non-obedient myself, I could pay someone 400 bucks to do it for me ! Ok, I'm game for just about anything , and since I pay handlers about that for a weekend anyway, what the heck.

So, after breed judging I meander over to the "other side" and see a crowd of people at the entrance of a ring. Okay, first odd thing that sits in my brain is....this is supposed to be a dog event, yet there are no dogs anywhere near this crowd of people. Some 10-15 people are crowded around a little lady at the ring entrance with rapturous looks on their faces. With the intent looks they are giving her, she must be telling them about an awesome lunch being prepared just for them ! Okay, okay, my stomach was growling since I hadn't fed it yet that morning and stomach talks to brain which relays it to the eyes. What can I say.

Oddity number two hits just then. ALL of these people without dogs, follows this lady into the ring to look at what is referred to as "stations" . They all spread out and walk around little signs laid out around the ring in no apparent order. Evidently I am not the only one who refuses to follow directions, so these signs tell these people without a single dog present, to do really weird things like stop....step back 3 paces....sit....advance and down....turn around....stand....turn left...turn right....spin and sit...weave...and it goes on all over the ring. Now, I have a warped sense of imagination and the sight just tickled me to no end ....at first. My first rabid thought as I watched all this was .....well, never mind, rabid thoughts have never been pretty ! The woman they were so enthralled with, is actually a choreographer in real life. Welcome to the new sport of .....Rallet Ballet.



Now, you've got people in there of all ages and body types, and no way shall I ever be one of them . I picked out the first person to watch. She approached a sign with an intent look on her face, tongue slightly between her teeth in deep concentration. Then it got.... downright weird. Her right arm slowly raises as the right hip rotates outward ever so slowly. The right arm as it reaches full extension above the head with the hand slightly bent towards the left, swoops forward as the right foot with toes pointed sweeps towards the left and a perfectly executed pirouette is performed as her eyes stay pinned on the sign. ## The Comprehensive Breed Health Survey For The German Shepherd Dog

The Comprehensive Breed Health Survey for the German Shepherd Dog was created to gather information in order to better identify the health issues plaguing the breed, how common these are and what role environmental factors may play in those issues. The interest is neither political nor monetary, but scientific as an aid in maintaining the integrity of the purebred dog. The purpose of this survey is to help German Shepherd owners, breeders and veterinarians educate themselves.

This survey is extensive, including information about diet, vaccinations and chemical use, as well as a multitude of health issues. As a result, the survey is quite lengthy. However, the length is warranted to insure all important information is included. We know so very little at this point about how common various diseases/disorders are in our breed, or what environmental factors may be part of the issues. This survey is a first step in providing those answers.

All individual information provided will be strictly confidential. Information accumulates in a specially created database for future compilation. The compiled data will be made available to all participants who request it, via email, and will also be on the website so that the general public may have access.

We are asking that anyone with a purebred German Shepherd participate in the survey. Any German Shepherd that has lived in your home on or since January 1, 1998, whether rescued, unregistered or registered, is eligible and welcomed. Absence of a pedigree does not exclude anyone. Can't find your AKC or other registry paperwork? Please participate anyway. Simply leave those areas of the survey blank.

The submission deadline is May 31, 2008. It is our hope that, by then, we will have data for a nice cross section of the German Shepherd population. Needless to say, the more surveys we have, the better the information in the final report will be. So please get those surveys turned in! Think how good you'll feel knowing that you made a difference. There's nothing to lose and everything for our breed to gain. Thank you for participating.

### AMERICAN CANINE FOUNDATION LEGISLATIVE UPDATE MARCH 2007 WILL WE BE ABLE TO SHOW AND BREED DOGS IN THE FUTURE ?

Breeding restrictions are being passed everywhere, "MANDATORY SPAY AND NEUTER" laws are surfacing all over. Breed bans are being attempted all over the United States.

WHAT WILL IT TAKE TO STOP OUR RIGHTS FROM BEING TAKEN FROM US ?

Can we as Dog Fanciers win the fight against the animal rights campaign intended to stop canine ownership ? (YES)  
Mandatory spay and neuter serves no legitimate governmental purpose, it does nothing to protect the public, it is unconstitutional and needs to be correctly litigated in court to stop it.

Why is it unconstitutional ? Neutering or spaying a canine will not reduce human aggression, when its mandated to the public animal control agencies end up seizing so many canines that shelter intake numbers increase over 100%, budgets to maintain attempted enforcement increase and tax payers money is wasted. Mandatory spay and neuter of your pet forces you to have a surgery performed on your pet that can cause serious medical problems in the future development of the canine. Forcing you to alter your pet with surgery is violating your rights and causes damage to your property without a rational basis. Mandatory spay and neuter is promoted by the animal rights movement to aid in ending domestic pet ownership. When governmental agencies enact mandatory breeding laws they target the Dog Fancy, the responsible breeders who obey the laws. The Dog Fancy is forced to obtain breeding permits with requirements that can't be complied with which in return stops purebred dog breeding. Irrational thinking is behind the mandatory spay and neuter campaign fueled by PETA/HSUS and other animal rights organizations.

In California at this time animal rights legislation is passing taking all breeding rights of Dog Fanciers away and placing it in the control of animal control agencies !!!! LA County passed mandated sterilization laws with breeding restrictions, Riverside County is proposing it, Kern County is proposing it, Sacramento and Orange County are being lobbied by AR Organizations. AB1634 was introduced this year to stop canine breeding.

From: ACF

The American Canine Foundation was founded in 2000 to protect the Dog Fancy's rights to own canines. ACF is the only organization to successfully litigate constitutional challenges against breed bans

2001 ( ACF v Pontiac ) Case settled breed ban repealed.

2002 (Tack v Huntsville) Alabama Supreme Court affirmed the trial court decision that no breed of canine is inherently dangerous

2004 (Margolius v Denver) ACF proved Denver can't identify a breed of canine (Amstaffs / APBT's )

2006 ( Tellings v Toledo ) BSL was ruled unconstitutional by the Sixth District Court of Appeals. The case is appeal and will be appealed to the US Supreme Court if needed

ACF has filed a federal lawsuit against the State of California and Los Angeles County to challenge mandatory spay and neuter laws with breeding permits that require turning all registration papers over to animal control who then can either approve or deny your right to breed your canines. (ACF v Ben Sun, Los Angeles Co, San Francisco) Northern District Federal Court. At this time AKC Kennel Clubs are being forced to turn over their data to LA County AC and must provide their member data bases.

The American Rottweiler Club, the Shorline Kennel Club, the Golden Retriever Club of Greater Los Angeles, the Western Rottweiler Owners, the Lake Matthews Kennel Club, the ADBA and countless Dog Fanciers from California and other states have donated substantial amounts to fund ACF's California lawsuit.

#### ACF AGENDAS 2006 / 2007

In August 2006 ACF through their Colorado attorney filed a federal lawsuit against the city of Aurora citing several constitutional rights violations. The Commerce Clause is being argued regarding the 10 AKC breeds and anything that looks like them that Aurora banned. Plaintiff's in the case are ACF, Tina Villani and Florence Viazon. Experts used will be Dr Brisbin PhD, Dr Milani DVM, Dr Al Stinson DVM Professor of Veterinarian Medicine, Jim Crosby, Jan Cooper, Glen Bui and Dr Estep PhD.

ACF is filing a federal lawsuit in the State of Washington, King County passed a mandatory spay and neuter law several years ago, its failed and cost tax payers wasted money.

ACF is filing a state level lawsuit against LA County in the Los Angeles County Superior Court asking for a temporary restraining order. LA County has been enforcing their mandatory spay and neuter law and has targeted an ACF member in LA County who will be named as a Plaintiff on the case. The case will be filed before April 2007 with a Plaintiff who owns an AKC registered Poodle.



ACF has pending a constitutional challenge in Ohio where the Sixth District Court of Appeals ruled BSL violates equal protection, substantive due process, procedural due process and the vague doctrine along with the right to be heard. The case is in appeal and ACF is prepared to take the case to the United States Supreme Court to stop BSL.

You may think that your breed of dog is exempt from animal rights legislation in your city, and everything is just fine? If you do you would be closing your eyes to the real problems of today. Laws are being passed by the animal rights agenda to change owner to guardian, ban breeds of dogs, restrict breeding and end domestic dog ownership in our country every year.

Dogs can be found most anywhere: curled upon, exploring underneath, wriggling out of, racing to, digging at, peeking around or hiding in. Their owners worship them. Some try to ignore them. Because dogs bark, neighbors hate them.

A dog is innocence with a full roll of tissue unraveled at its feet. He is obedience sleeping on a forbidden bedspread, wisdom with a wagging tail, beauty with mud on his feet. When you are busy, he wants to be let out. Once he's out, he wants back in. When you want to impress someone with his intelligence, he forgets absolutely everything he has ever learned. He likes golf balls, upholstered furniture, anything made of rawhide, warm beds, long walks, table scraps, other dogs and paper of any variety. He does not care for the obedience school, chain collars, leashes, baths, nail trimming, strange surroundings, vaccinations, lack of companionship, cold weather or thunder and lightning.

You can banish your dog to his pen, but you can't banish him from your heart. You may have bought him, but he owns you. Your dog was supposed to be your pet, but he enslaves you. When you return after an absence, short or prolonged, your dog will overwhelm you with warm affection and squirming enthusiasm. Your dog can muss up your home, your hair, and your dignity. He can cause you to spend money, time and temper; and then, just when your patience is ready to crack, a wag of his tail, and you're lost again.

# Legislation Updates

## Dog owner takes on town's pet ordinance

Eleanor Herrick is meeting with an attorney today to explore what legal action she can take to keep more than two dogs at a home in the town of Holland.

On Friday, she had made plans to sell five of her seven dogs in order to be legal under the town's dog ordinance, but changed her mind over the weekend.

"It has pretty much ripped my heart out," said Herrick, 42, who attended two recent town board meetings in an effort to find a way to keep all of her seven dogs. "In a lot of ways it's like having kids taken, which isn't a fair comparison to people who have actually lost children, but it hurts."

In 2005, Herrick moved from Isanti, Minn., back to the home where she grew up to take care of her mother, who had lymphoma and needed a bone marrow transplant. She brought her miniature schnauzer and six Labrador retrievers, which joined her mother's Tibetan Spaniel in the home at W 7421 Kip St., Holmen, Wis. The eight dogs are indoor dogs and three of Herrick's were rescued dogs, one after Hurricane Katrina.

When she was updating her dogs' shots this winter, she was told about the dog ordinance, which limits dogs older than five months to two per individual or family living together. Anyone wishing to house three or more dogs must apply for a conditional-use permit from the county of La Crosse, which Herrick did in January.

"People didn't realize I had dogs until they got a note from the county," Herrick said. Neighbors "protested on the basis of potential noise and potential odor. They had been living next to these dogs without any knowledge of noise or odor for 14 months." Herrick, who trains and competes her personal dogs, said while she didn't seek to set up a breeding and training facility implied by the permit, she was willing to do so to keep her dogs. But at a board meeting Wednesday, March 14, supervisors Kathy Dummer, Jim Lakey and Jim Halvorson voted down a motion by supervisor David Carlson to allow Herrick to register her four personal dogs and get rid of her three rescued dogs within 60 days.

Although six people in the township legally own three dogs, their variances were granted before a meeting on June 9, 2004, when that board passed a motion to stop considering variances on the dog ordinance. The decision, said Marilyn Pedretti, town clerk, happened after an influx of requests for variances.

"The current conditions truly create criminals out of responsible dog owners," Herrick, a nurse at Community Memorial Hospital in Winona, said at the March 14 meeting.

George Hammes, town chair, said in about a year and a half, no one had complained about Herrick's dogs. "Personally I think we should review our dog ordinance," Hammes said. He plans to create a committee of board members and citizens to review the dog ordinance, and said Herrick would be a good candidate for that committee.

Dummer expressed concerns that since the ordinance allows for two dogs, liability would rest with the town if they allow more than that. "Once we get to more than two animals, the problems that can arise do arise," Halvorson said.

Herrick said some of her dogs are now at a commercial kennel. She said the town board members "need to remember that their roles have real effects on real people's lives."

The Town of Holland has about 700 dogs, said Marie Dummer, town treasurer.

## AMERICAN CANINE FOUNDATION LEGISLATIVE UPDATE MARCH 2007

### WILL WE BE ABLE TO SHOW AND BREED DOGS IN THE FUTURE ?

Breeding restrictions are being passed everywhere, "MANDATORY SPAY AND NEUTER" laws are surfacing all over.

Breed bans are being attempted all over the United States. WHAT WILL IT TAKE TO STOP OUR RIGHTS FROM BEING TAKEN FROM US ? Can we as Dog Fanciers win the fight against the animal rights campaign intended to stop canine ownership ? (YES) Mandatory spay and neuter serves no legitimate governmental purpose, it does nothing to protect the public, it is unconstitutional and needs to be correctly litigated in court to stop it.

Why is it unconstitutional ? Neutering or spaying a canine will not reduce human aggression, when its mandated to the public animal control agencies end up seizing so many canines that shelter intake numbers increase over 100%, budgets to maintain attempted enforcement increase and tax payers money is wasted. Mandatory spay and neuter of your pet forces you to have a surgery performed on your pet that can cause serious medical problems in the future development of the canine. Forcing you to alter your pet with surgery is violating your rights and causes damage to your property without a rational basis. Mandatory spay and neuter is promoted by the animal rights movement to aid in ending domestic pet ownership.

When governmental agencies enact mandatory breeding laws they target the Dog Fancy, the responsible breeders who obey the laws. The Dog Fancy is forced to obtain breeding permits with requirements that can't be complied with which in return stops purebred dog breeding. Irrational thinking is behind the mandatory spay and neuter campaign fueled by PETA/HSUS and other animal rights organizations.

In California at this time animal rights legislation is passing taking all breeding rights of Dog Fanciers away and placing it in the control of animal control agencies !!!! LA County passed mandated sterilization laws with breeding restrictions, Riverside County is proposing it, Kern County is proposing it, Sacramento and Orange County are being lobbied by AR Organizations. AB1634 was introduced this year to stop canine breeding.

The American Canine Foundation was founded in 2000 to protect the Dog Fancy's rights to own canines. ACF is the only organization to successfully litigate constitutional challenges against breed bans

2001 ( ACF v Pontiac ) Case settled breed ban repealed.

2002 (Tack v Huntsville) Alabama Supreme Court affirmed the trial court decision that no breed of canine is inherently dangerous  
2004 (Margolius v Denver) ACF proved Denver can't identify a breed of canine (Amstaffs / APBT's )

2006 ( Tellings v Toledo ) BSL was ruled unconstitutional by the Sixth District Court of Appeals. The case is appeal and will be appealed to the US Supreme Court if needed

ACF has filed a federal lawsuit against the State of California and Los Angeles County to challenge mandatory spay and neuter laws with breeding permits that require turning all registration papers over to animal control who then can either approve or deny your right to breed your canines. (ACF v Ben Sun, Los Angeles Co, San Francisco) Northern District Federal Court.

The American Rottweiler Club, the Shoreline Kennel Club, the Golden Retriever Club of Greater Los Angeles, the Western Rottweiler Owners, the Lake Matthews Kennel Club, the ADBA and countless Dog Fanciers from California and other states have donated substantial amounts to fund ACF's California lawsuit.

### ACF AGENDAS 2006 / 2007

In August 2006 ACF through their Colorado attorney filed a federal lawsuit against the city of Aurora citing several constitutional rights violations. The Commerce Clause is being argued regarding the 10 AKC breeds and anything that looks like them that Aurora banned. Plaintiff's in the case are ACF, Tina Villani and Florence Viazon. Experts used will be Dr Brisbin PhD, Dr Milani DVM, Dr Al Stinson DVM Professor of Veterinarian Medicine, Jim Crosby, Jan Cooper, Glen Bui and Dr Estep PhD.

ACF is filing a federal lawsuit in the State of Washington, King County passed a mandatory spay and neuter law several years ago, its failed and cost tax payers wasted money. ACF is filing a state level lawsuit against LA County in the Los Angeles County Superior Court asking for a temporary restraining order. LA County has been enforcing their mandatory spay and neuter law and has targeted an ACF member in LA County who will be named as a Plaintiff on the case. The case will be filed before April 2007 with a Plaintiff who owns an AKC registered Poodle.

ACF has pending a constitutional challenge in Ohio where the Sixth District Court of Appeals ruled BSL violates equal protection, substantive due process, procedural due process and the vague doctrine along with the right to be heard. The case is in appeal and ACF is prepared to take the case to the United States Supreme Court to stop BSL.

You may think that your breed of dog is exempt from animal rights legislation in your city, and everything is just fine? If you do you would be closing your eyes to the real problems of today. Laws are being passed by the animal rights agenda to change owner to guardian , ban breeds of dogs, restrict breeding and end domestic dog ownership in our country every year.

# PAWS OFF!

Joshua and I just made a little trip.

On Valentine's Day Joshua went with me right into the Rayburn Office Building (US Reps, Washington, DC) and we met our representative, Mr. Ed Whitfield. He seemed to appreciate Joshua very much, and shared with me that he has terriers! We also visited offices of some other KY reps, and a few from other states as well. Joshua behaved like an angel, as always. We visited some offices of reps for states where we've shown before, or traveled through. The ladies at one office (Oregon I think, one of the very few states we've never been to) were particularly taken with Josh, and sat on the floor with him in one of their laps, having a regular ear mooshing 'love in' with him.

One of the things I mentioned in almost every office I visited was the fact that most of this legislation is being 'sold' as a way to 'fix' the puppy mill 'problem'. But the commercial breeders are **ALREADY** regulated by USDA, and those breeders are **NOT ALLOWED** to have their breeding dogs or puppies **IN** their homes. What most of this legislation is going to do is make it all but impossible for those who breed dogs and raise them in their homes as a hobby, and because they love them. And these are the folks who are producing the majority of the well bred, high quality, and well socialized pets. Most of us take life time responsibility for puppies we breed, and most of us also do some (or a LOT of) volunteer rescue work as well. Most of us do **NOT** make money - it is a (usually) very expensive hobby. To a few, I also mentioned that as a **TAXPAYER** I do not want to pay for more federal government bureaucracy to regulate **HOBBIES**. I also mentioned to a few of them that I'm one of the tens of thousands of dog and cat fanciers from around the world who 'helped' Santorum out of his office because of PAWS (and I usually vote **RE-PUBLICAN** and I **DO NOT** live in his state!). Also told them we will do that again if necessary. Mentioned to some of them that Joshua is here to tell you he does not want a government microchip stuck in him. The next day, we also visited one of our state senator's offices, and though we didn't get to meet with him, we talked with staff there, and left our card & flyers. We visited a few other offices that time as well. I think a LOT more dog folks should drop in (maybe with a dog, if you have a very well behaved one who can be a Service Dog), and visit and share some opinions. The ARs who are trying to take away all our rights have tons of money (100s of millions), and full time paid lobbyists.

But the pet owners & lovers of America have a huge advantage, too. There are **SO MANY** of us! The ARs will **NEVER** manage to get enough money to hire anything like the tens of millions (probably at least 100 million) pet owners there are in this country. Though most pet owners don't yet realize exactly what's going on, once they find out they may no longer be able to find home raised pets, they **WILL** wake up.

There is **NO** reason **CITIZENS** can't lobby too. We don't have to be paid. Heck, we joke about our (high 5 figure) 'dog mortgage', and it really is no joke. Making a trip or two to DC or Frankfort (my state capitol) is a **VERY** small price compared to our ongoing \$ expenses related to our Afghan Hounds, and our already **HUGE** time commitment to them. We are going to **LOSE** our dogs(!) if we don't stop the ARs. But **IF** I continue to be the only one doing these things, it may not be enough. I will bet if **LOTS** of folks start doing this sort of thing, our lawmakers **WILL** sit up and take notice. The squeaky wheel gets the grease! We **MUST** all start being **VERY SQUEAKY** wheels, and maybe we can **BURY** the ARs under the grease, or get them stuck in it. .

Even if you don't have a service dog you can bring, if you get the chance, go anyway without a dog. Bring pretty pictures, and tell them how important it is to you to continue to be able to get (or produce) home raised pets. Also, tell them your pets are private property, and you don't support the animal rights agenda ala peta, hsus, etc. They **DON'T KNOW** that hsus is **NOT** out to help animals, but to end all our rights. Tell them (the Feds) your pets do **NOT** want a government microchip - this is **AMERICA**, and they are **PRIVATE PROPERTY**. Also, as a **TAXPAYER** you don't want to pay for microchipping every privately owned chicken, cat, dog, horse, pig & cow in America. **BRING** some business cards (doesn't have to be for a business, can be just your personal contact info) & literature, or flyers so you have something to leave in case you don't get to meet your legislator personally. Though the ARs have so much money, and paid lobbyists, they only have a (relatively) FEW lobbyists. Every pet owner in America could do a bit - visit once a year or something. If LOTS of folks wake up and make that effort, our lawmakers WILL smell the coffee. WE ARE the voters - no matter HOW much pac money they get from the ARs. Also, you can usually arrange to visit your legislators when they're at home in your district. The big advantage of going to the Fed. or State Capitol is being able to also visit OTHER state's (or county's) legislators. Even though you may not live in a state, you travel through and visit many of them, and buy products from them. Mention that. Also, these days with the internet, it IS possible for folks from all over the world to band together to help get a particular legislator voted OUT. We proved that with R. Santorum.

Suggestions for when visiting. Dress nicely, and speak politely! Find something to be complimentary about, and thank the person(s) for the job(s) they are doing. Then, share politely about your issues. Keep visits short, unless staff or your rep has time and wants to go into more depth on the issue with you. We didn't want to wear out our welcome, besides, there are SO many offices there to visit, and usually not nearly enough time due to 2 hour parking meters. Good idea to bring a dog IF you have one with exemplary behavior. Anything else might do more harm than good for your cause. (if you have a dog be SURE to have baggies! Also, I was told when I was going in that signs are not allowed. (I told them Joshua was a service dog & constituent with a message for our congressman :) They asked me to take Joshua's blanket off him till I got to the congressman's office, which I did. It has Velcro straps. I put it back on him outside the door of our rep's office, then left it on him till we were leaving the building. LOTS of folks in the hall stopped to ask about him, and some petted him, I handed out cards & flyers there as well. All were very nice. If you don't bring a dog, bring some nice PICTURES. Bring KIDS if you have some well behaved ones. It's a GREAT civics lesson for them, and they ARE constituents & future voters.

Maybe this can be adapted for other countries - I don't know how things are in other places.

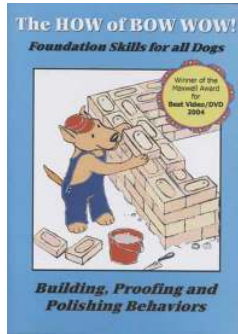

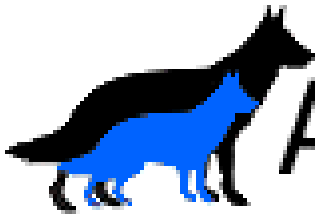
